Repayments

Repayments are made over a period of 1 to 5 years and have a fixed interest rate of 6%. For example, the monthly repayments on a £5000 loan would be:

Loan Period	Monthly Repayment
12 months	£430
24 months	£222
36 months	£152
48 months	£117
60 months	£97

Eligibility

A Start Up Loan is an unsecured personal loan for business purposes. Individuals can receive one loan, however more than one partner in a business can apply for a loan.

Eligibility:

- You must be aged 18 or over
- You must be living in England, Scotland or Northern Ireland*
- You will have an idea for a new business or a business that has been trading for less than 2 years
- Most types of businesses will be considered
- We will conduct a credit check, although we do not credit score (if you are concerned about this please contact us)
- If you are a foreign national you must have a relevant visa that extends at least 6 months beyond your loan repayment term

*Sorry, but we don't cover Wales at the moment.
